School Circular for May (F.2)

Please take note of the following issues.

(1) Special Timetable for 10th May 2019 (Friday)

10th May (Friday) will be the special timetable day, class will dismiss at 1p.m.. School Self-evaluation Meeting will be held in the afternoon and there will be no school in the afternoon.

(2) Catholic School Teachers' Day 2019

16th May (Thursday) will be the Catholic School Teachers' Day, students have no classes on the day.

(3) The Feast of Our Lady Mary Help of Christians

The Feast of Our Lady Mary Help of Christians will be held at St. Jude's Church, North Point at 10:00a.m. on 24th May (Friday), which is an important religious celebration of our school. There will be no class in the afternoon. Parents are welcome to join the ceremony and praise the Lord. (4) Physical Education examination of the final term

The Physical Education examination of the final term (written test) is scheduled to conduct in the morning session of Class teacher period on 29th May (Wednesday)(Day 2). Other assessment is scheduled to conduct during the P.E. lesson. In case of bad weather, class suspension will be announced by the Education Bureau, the P.E. examination will then be postponed to the morning session of Class teacher period on 31th May (Friday)(Day 4). Enclosed is the assessment content of P.E. subject for parents' perusal.

Any students who are absent from illness are required to submit a Sick Leave Certificate issued by a doctor together with a Parents' letter, otherwise, no marks will be given and considered as absence from school without leave. (No further make-up arrangements are scheduled for late comers)
